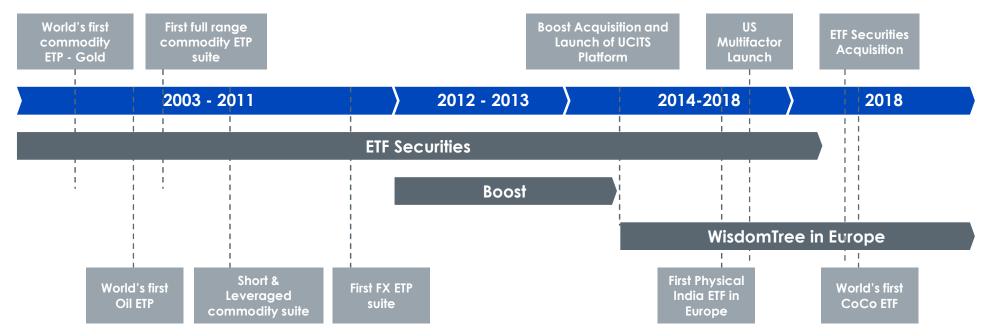


WisdomTree in Europe










